Western Region Social Service Forum (WRSSF) is the Social Development Wing of the Western Region Bishop's Council. It was initiated in 1996 and was registered in the year 2001 under the Societies Registration Act, 1860 and the Bombay Public Trust Act, 1950.

WRSSF works with 17 Partner NGOs from Maharashtra, Gujarat and Goa and the Union Territory of Dadra and Nagar Haveli. WRSSF acts as a Coordinating and Facilitating Organization and inspires, animates, supports and promotes the developmental interventions of its 17 Partner Diocesan Social Service Societies (DSSS) for the integral Development of people. WRSSF adopts an inclusive approach and does not discriminate anyone on the basis of caste, gender, religion, creed or linguistic groups. The Organization implements programs based on the developmental needs of the four zones of its operational area - Guiarat, Marathwada, Konkan and Vidarbha.

WRSSF helps the Partner Organizations to build up strong organizational system by formulating relevant policies and procedures. It also gives hand holding support to the Partner Organizations on various thematic areas such as Sustainable Development, Local Resource Mobilization, Strategic Planning and Project Implementation etc. by networking with the Government, Corporate and other Funding Organizations.

WRSSF has focused mainly on three objectives for this year and that is Media Visibility by promoting it to the Partner, which in turn yielded positive results from the Partner Organizations. The second objective was on building networks with Corporates for CSR - Connectivity, we have conducted trainings on Capacity Building for Partner Organization and Social Medias like Facebook, WhatsApp etc. are regularly update.



Sessions on dissemination of Four Strategic Key Pillars and strategic Plan of Caritas India

Fr. Dr. Jolly (AED-Caritas India) took the session on Four Key strategic Pillars of the Church. He gave detailed explanation on dissemination of strategic plan and launching of lantern Campaign program in every Diocese. Strategic plan is based on 4 pillars of the church.

Sessions on Models Of Holiness by Fr. Dr. Robert D'Souza

Fr. Dr. Robert D'Souza facilitates the session on Models of holiness, in that he briefly explained about Reflection on the strength and weaknesses of different eight models of Holiness. He starts the session with story of woodcutter, the mantra go deeper, deeper and deeper and sharing some Bible verse. In second session of models of Holiness, he explained about prophetic Charity Divine Justice, Divine love, Divine Hope, Divine Providence, Prophetic confrontation, Prophetic consolation, Prophetic suffering, Prophetic mission / submission. He concluded the session with asking questions to participants and comments from them.



WRSSF's Workshops and Trainings for its Partner Organizations

Soft Skill Development Training for Partner Directors

Venue: Montfort Sadan, Pune Date: 17th July 2019

WRSSF conducted a session on Drum Circle by Ms. Sherin M & Ms. Ann Anish for the Partner Directors. Drum circle is a unique leadership learning opportunity for experiencing the benefits of timing, listening, bonding and trust. The training of drum circle is scientifically designed to enhance the energy levels of every participant irrespective of age, gender. The participants were very thrilled and enthusiastic, the session was very entertaining and it is a great mode to work on Interpersonal skills, leadership skills, team building, focus, listening skills, non-verbal communication etc. Learning rhythms of drum circle have several key benefits like, creating a sense of community within the organisation, it uplifts the workplace morale,

improves communication skills, develops listening skills, encourages innovation, it helps in better team work and bonding and these skills would be very useful for the partner directors in order to implicate in their respective organisations. The session was fast paced and entertaining and kept every participant alert and interested.



India's Content, General Elections 2019 & Rollout Plan of Strategic Plan Key Strategic Pillars - Rev. Fr. Paul Moonjely

Venue: Montfort Sadan, Pune Date: 18th July 2019

Rev. Fr. Paul discussed briefly on the current political status of India, the elections of 2019 and its repercussions etc. Rev. Fr. Paul mentioned the strategic plan of Caritas India and spoke extensively about promoting volunteerism, strengthening Lenten campaign, engaging in dialogue and developing regional strategy plan etc. He gave several examples of existing campaigns like #Fridays for future, power angels, caritas Samaritan etc, and encouraged the directors to expand their Lenten campaign.



Session on Upcoming concerns in the field of Development by Professor Dolly James.

Venue: Montfort Sadan, Pune Date: 17th July 2019

Prof Dolly James intensively spoke about Child Rights and the four main sets of Rights of each child - Life & Survival, Protection, Development and Participation. Child rights are applicable to all children regardless of the background of the child. As a social worker, the prioritization should be done on the basis of community assessment and should be applied accordingly. She further elaborated on the Shifts in Approaches in terms with Needs based and Rights based, Participation and Non-Discrimination etc. She further emphasized that the way you mold them, makes them a citizen tomorrow. It plays an important role in the character modification of the child. The next topic was Sexual Harassment of Women at work place Act 2013 - Prevention, Prohibition, Redressal. Prof Dolly James gave an intricate insight into the Act, the importance of a complain committee in an organization and its essentials. She

further mentioned that harassment includes not just physical but mental and emotional harassment and the repercussions of the same. She also elaborated on the third gender, the unconscious exclusion of the third gender in the society, their right to worship as a fundamental right and about how we can include them in the society etc. The session was enlightening on many grounds considering the different social work fields that the directors have to work on and the many fields that needed to be tapped upon.



Motivational Training for Volunteer, Program for Youth

WRSSF in Collaboration with Kalyan Eparchy Youth (KEY) organized ENTHUZIA program for youths Volunteers on 23rd February 2020, at Canossa High school Andheri East. More than 800 youth were presented for the program from Mumbai and Other Diocese. The Objective of the program to encourage and motivate other Youth volunteer. Also they Launch website namely extramile.org.in for registration of the youth. WRSSF Director Fr. Dr. George Vattamattam,

stressed in his address that today's world need more youth volunteer to reach out with poor and Marginal of the society. Volunteers are playing great job to reaching out to needy people.

Fr. Dr. Jolly facilitates the session on Four Key Pillars of the Church and Volunteerism. Program was filled with lots of activity Dance, Singing and more other Activities. Virtual Platform Meeting for DSSS Partner Directors of the all three regions of Maharashtra, Gujrat, Goa and Union Territory of Dadara and Nagar Haveli. All 17 partner directors were present for the first virtual meeting during the pandemic situation of Covid-19 organized by WRSSF.

During Lockdown WRSSF decided to conduct first online meeting with all DSSS directors using virtual platform, to discuss the pandemic situation of Covid-19. Were Archbishop Thomas Macwan and Bishop Jose Chittooparambil was present for the meeting. The meeting began with prayer and welcome address by Fr. George Vattamattam. Archbishop Thomas Macwan and Bishop Jose Chittooparambil in their opening massage appreciate all the directors for their good work they had done in their particular DSSS during lockdown period.

Online Capacity Building on Covid-19 safety Practices for Partner Directors and Key staff

Venue: Virtual Platform Date: 9th and 11th May 2020

WRSSF strongly upholds it's mandated to strengthen Partner and support them in their tireless efforts to reach out to the most marginalized and vulnerable sections of society. As part of these efforts WRSSF in collaboration with Caritas India and CRS Team Organized online Capacity Building program for 17 DSSS Partner, Associate Partner and Key staff on Covid-19 safety Practices. Where all 17 DSSS directors and Key staff including WRSSF Bishop Jose Chittooparambil and Caritas India staff present for the program.

Mr. Kushal was the Resource person of the Program. The topic was covered Covid-19 Safety practices. The key objective of the meeting was to organized online capacity building program for the

DSSS partner's Directors and Key persons in order to conduct the same training at diocese level further.

It was primarily on Personal hygiene and instruction given by MOH and WHO. It covered aspects such as Knowledge about prevention from get infected with Covid-19 and interesting videos which gave more clarity to everyone. Session began with quiz activities, were CRS staff asked questions related to Corona Virus. Further session covered following aspect like, Must Do and Don'ts, Community Guidance, pre and post distribution instruction. At the end of the session, Mr. Kushal shows some examples and photos of field, that shows, how to deal with situation. And the session concludes with discussion and question / answer asked by participants.

Online Capacity Building program for Center for Social Action, Mumbai

Venue - Virtual Platform Date - 19th Jun 2020

In its endeavour of building the capacity as the focus area based on the strategic plan. WRSSF in Collaboration with CRS and Caritas India organised Online capacity building program on Covid-19 safety practices for the Partner DSSS and their frontline Key staff. Mr. Kushal was the resource person of the program. Program was organised for DSSS partner centre for Social Action and their

frontline staff, this program was attended by 18 frontline staff of partner organization CSA. Program was all about how to prevent with corona Virus and the personal safety during this Covid-19 situation. All the CSA partner organisation staff appreciated the workshop and they actively participated, as they understood the importance of Covid-19 safety practices. It was a great learning for everyone and all the staff decided to implement at their work places.

Exposure Visit for WRSSF Partner Directors

Venue: Vasai, Umed Date: 27th January, 2020

All the 17 Partner DSSS Directors along with the WRSSF Director Fr. George Vattamattam visited the Umed. Umed is specially designed centre for differently abled run by the diocese Vasai. It caters to the unique requirements of individuals belongings to all religious communities. It is NGO for physically challenged people in Mumbai. The purpose of the visit was to have an in debt



understanding of the administrative and programmatic aspects of the Umed centre. During the visit were all participants welcomed by wearing them cap by differently abled people which who part of the Umed Centre, and there was detail presentation of the Program functioning by the Umed centre. The visiting team appreciated the efforts of the Forum for providing such strong support in the development of all its Partner Organizations.



WRSSF Resource Mobilization Initiatives

Proposal Submission

WRSSF submitted Project Proposal on the issues of EDUCATION to OPC Assets Solutions, Pvt. Ltd, seeking their support to intervene in DSSS regional Partner. OPC Assets Solutions have already Accepted and agreed to support the 5 Partner Diocese.

Response to Maharashtra Flood

WRSSF contribution Towards Maharashtra Flood

In the month of August, there was heavy rainfall in all over Maharashtra, which was cause to huge floods in so many places of state Maharashtra. However, the worst affected was the Kolhapur and Sangli district which was completely submerged by the flood water and suffered heavy loss of life and livelihood.

During the flood, WRSSF Director Fr. George visited to various part of the Flood affected areas of Kolhapur and Sangli DSSS. Also, he took part in relief material distribution for the flood affected people.

WRSSF had collected 2 truck Flood relief material and send to Sangli and Kolhapur flood affected people in the months of August and September as an immediate relief help. Also, WRSSF had given 1 lack rupees each to 3 Partner DSSS organization.

Sangli Mission Society (SMS): Successfully completed the project in collaboration with Western Region Social Service Forum for affected

villages through the need assessment and situation analysis. Based on the survey we identified that people were in need of wash kit and utensils kit as an immediate relief assistance. A number of 580 families got benefited through this distribution.

Sindhudurg Diocesan Development Society (SDDS): In the month of August, Maharashtra was battered by heavy rainfall and many districts in Maharashtra were submerged under water and suffered heavy loss to life and livelihood. But the worst affected was the Kolhapur, Banda, Pune and Shengaon. After the situation was known by Sindhudurg Diocesan Development Society (SDDS), the following activities were conducted. Transit walk was conducted of the flood-affected regions, area survey was conducted, and daily necessities were distributed to the worst affected families by the hands of the Chairman of the Diocese of Sindhudurg, Bishop Alwyn Barreto, along with the Coordinator Mr. Rajendra Kamble

All those activities conducted under safety measures. WRSSF first gave all available safety instructions to all volunteers, after that WRSSF staff distributed hand gloves and Face Mask to all volunteers.

CENTRE FOR SOCIAL ACTION (CSA), MUMBAI, MAHARASHTRA

MAJOR INTERVENTION OF THE YEAR 2019-2020

MAAZA MAHARASHTRA MAAZA SAHABHAG

After a positive response for the first state forum, Center for Social Action, networked with the partner organizations to facilitate, the second state forum under the banner Maaza Maharashtra Maaza Sahabhag.

In collaboration with PRATYEK and technical support from UNICEF, a two-day residential program was organized on 4th and 5th of January 2019 which saw a participation from 18 children and 10 facilitators representing 9 partner organizations.

Over the two days, the children were given training on soft skills, like basics of reading body language, posture and presentation and through various games and activities they were taught on how to communicate with people and the importance of complementing each other. The children were divided in groups and were asked to read a section from the Charter of Demands, discuss amongst themselves and then share the same with everyone.

For the exhibition, the children were asked to categorize all their rights into four categories, namely, Rights of Survival, Rights of Development and Right for Protection and Rights for Participation. The children drew a life-size tree depicting these rights based on Charter of Demands.

They also prepared clay models depicting these rights and spoke about these rights confidently to the people who visited these stalls. The State Forum and the exhibition concluded with a # VOTE FOR ME campaign where the audience who came for the exhibition signed a petition that they will vote for the political party who will include children issues and opinions in their political manifestos in the upcoming Maharashtra State elections.




NASHIK SOCIAL SERVICE SOCIETY, NASHIK, MAHARASHTRA

MAJOR INTERVENTION OF THE YEAR 2019-2020

In March 2019 Bishop Savio conducted an input session for the Youth on Personality Development. He also spoke to the youth on their dedication and contribution towards the church. This was held St. Patrick's church, Deolali.

In June of 2019 an awareness drive was held in surgana on cleanliness for the village people. The children of the village were explained the importance of the studies and were given notebook, School bags, Compass boxes and even uniforms. The youth were taught to make chocolates, clothes washing



powder and harpic. This they sold to earn their daily living. The middle-aged people were taught to make big and small paper plates. In July 2019 on poultry project was started for the villagers in which family was given 4 and 5 hens and were told to increase the numbers in order to make their livelihood.

From August 2019 to January 2020 two batches of tailoring classes were held from Monday to Friday in Deolali at various tailoring centre for the women in the around Deolali. Fabric painting and paper bag making was also taught in batches. Some were helped with putting up flourmills. Many were also helped to build their houses. Girl students were sent to Bangalore to train as nurses – their fees were paid for the nursing courses.

For the youth of Deolali and Nagar career guidance courses were held by Cassandra warring in October 2019. Andrea D'Souza conducted a seminar for young girls facing' the challenges of the world as a women' in December 2019. In December 2019 there was a reunion of villages of Surgana at Deolali. These people were given a talk on "Salvation history". In January 2020 a session was held to teach some villagers how to make phenol and paper plates and also tailoring classes were held. Micrograin farming on trial error bases was done in February 2020. Exposure to farming of the farmers for the and by the farmers was held at Sahayadri farm. Peoples from villagers and teachers from Goa attained this session. This help making agriculture sustainable for marginal farmers by providing direct access to markets and serving the consumer.

KARUNYA TRUST, KALYAN, MAHARASHTRA

MAJOR INTERVENTION OF THE YEAR 2019-2020 GYANSAATHI

SAVLI

From project, SAVLI 26 HSC and 45 SSC students have passed out this year. 32 HSC and 52 SSC student had appeared for the year 2020 examination. Our children's come from vulnerable family backgrounds affected with life threatening diseases, which has pushed some of the children to become orphans so early in their life. Facing all these odds in life, they have made efforts to successfully complete HSC and SSC through the support of Project SAVLI. We at Karunya Trust are Elevating their dreams by reinventing their Goals.

MAJOR INTERVENTION OF THE YEAR 2019-2020

1. Can Survive: Campaign launched on 30th June 2019

Can Survive is a Goa centric movement, voluntary and community based with a vision of being a ray of hope in the fight against cancer so as to make a positive impact in bringing down the incidence of Cancer in Goa. Can Survive has two dimensions that one can survive from getting cancer and that one can survive even after getting cancer.

It aims to offer a Holistic approach, emotional support and medical aid and through early detection of cancer through education and camps, create awareness that cancer is preventable and curable. Can Survive desires to coordinate with other existing health and cancer networks so as to widen the outreach.

2. Centre for Deafblind, South Goa: Initiated on 1" November 2019

Our dream of initiating Caritas Goa Deafblind Services in South Goa finally dawned. On 1° November 2019, we began services from our newly set-up Centre at Borda, Margao. Home based and Centre based services besides physiotherapy are provided to the deafblind.

With the Margao based Centre, now we have covered entire Goa with the deafblind services. Caritas-Goa is the only organization in Goa serving the needs of the deafblind children and young adults. This venture is supported by Thomas Cook India.

3. Childline Railway Help Desk, New Office inaugurated on 2rd November 2019

The Child Help Desk at the Railway Station in Margao is operative form June 2018, however we inconveniently functioned without a formal office. Besides enabling better facilities, the office space facilitates needs of those staff particularly on night shifts.





SINDHUDURG DIOCESAN DEVELOPMENT SOCIETY, SAWANTWADI

MAIOR INTERVENTION OF THE YEAR 2019-2020

Community organized programmes under democratic governance

- People of Kalambist came together and solve their long pending issue of Animal Husbandry Doctor.
- Gram Panchayat Office started functioning with the efforts of the people at Terwan Medhe village.
- 23 people from Hewale village were guided and evaluated on SRI Pattern of Paddy Plantation by Mr. Hanumant Yashwant Gawas on 2nd April 2019.
- On 3rd April 2019 meeting held in Medhe Grampanchayat at 10.00 a.m. 11 people were present. They discussed on Panlot Yojana and gave them the related information they formed a group and listed the name below. Then on 4 April 2019 meeting was taken at Sonawal village on the same related topic 16 of them were present in that meeting.
- At Sawarwad village of Sawantwadi Taluka 57 people attended Gram Sabha and resolution was passed to pay Gram Panchayat Taxes like House and Water Tax. Application submitted to get water on a regular basis from SanamTemb Dam.
- RTI training was held and the villagers have filed RTI on different issues like social welfare department, workshop was taken on RTO for the villagers.
- 16 male and 6 female from Sawarwad village came together and cleaned the road at Parabwadi Shirshinge.



Sustainable agriculture

- 27 people from Verle come together and constructed a small dam for storage of water.
- 32 people of Sawarwad approached Tahsildar and BDO seeking their intervention to complete bandhara (traditional water storage) work. The work was sanctioned, later.
- 5 farmers from Jambhavade applied for fruit plantation under MGNREGA.
- Villages like Kalambist, Hewale, Bhadgaon, Verle, and Sawarwad motivated and guided farmers to traditional and organic farming.
- 10 farmers from Bhadgaon and 12farmers from Kalambist received red gram and turmeric seed from Gram Panchayat.
- People from Terwan Medhe village are practicing organic farming and are using 60% of dry cow dung for the vegetable cultivation like chilies, radish, onion, red leafy vegetable.
- 48 people attended awareness programme on promotion of organic farming from Terwan Medhe, one of the villages, and 22 farmers are doing

- traditional farming.
- 15 people from Bhadgaon Budruk and Jambhavade village demanded to build Bandhara for irrigating crops.
- 52 people are collectively taking steps to drive off elephants at Terwan Medhe Village.
- 29 people planted traditional chilly at Ghatewadi and Sonawal Village.
- 21 people planted finger millet in 60 Guntha (8 Guntha = 1 acre) at Ghatewadi village.
- 256 people attended Krishi Melava (agriculture festival) at Hewale Village.
- 46 farmers from Verle, 18 from Kalambist, 11 from Sawarwad are selling milk to Gokul.



SOCIAL SERVICE ADIVASI SOCIETY, KHANWEL, (DADRA & NAGAR HAVELI)

MAJOR INTERVENTION OF THE YEAR 2019-2020

- Computer course for the youth and Tuition classes for School Children. This was our 5 year project supported by the Society of Pilar, Nagar Haveli. The main aim of the project was two-fold.
- To give facility for the unemployed youth in learning Computer Basics.
- The second main goal of the project was to reach out to the poor Adivasi children in various villages.

Hence, during last financial year we had 31 tuition centers. Around 800 adivasi children benefited from these tuition classes, and 31 youths as part time tutors. Rs. 3, 49,000/- spent on this activity.

Computer Course: 3 months certificate computer course was conducted for the unemployed youth. 150 candidates registered and successfully completed the course in 10 batches. At the end of 3 months course, we had organized half day outing cum seminar for these students. 140 students gathered together and had a great time. Session was conducted to enhance life and not to destroy it for any reason and in any circumstances. Rs. 2,55,000/- spent on this activity.

With the collaboration of RDC, we had organized one-year training program for the leaders in Khanwel. UMID foundation based in Mumbai

- undertook this training program. 18 participants benefitted from this activity.
- Diploma course in Home- Nursing: 8 Adivasi students from the mission of Daman were motivated, guided and sent to Goa for Home nursing in St. Brijid Institute of Nursing affiliated Caritas Goa. 5 girls and 3 boys benefited from this project.
- Free fitters' course in Daman: Five boys were guided and sent to Daman for 3 months free course in plumbing and fitters.

Covid-19 pandemic response: we have reached out with ration and other basic needs of 30 migrant families. Rs. 15,660/- spent from the organization.


