#### Report of the Activities: April 2001 - March 2002.

#### Introduction.

The main thrust of this period was capacity – building at different levels in the Region. The Regional Perspective Planning (RPP) that was held by the WRSSF in January 1999 brought to light the need for capacity building for the personnel involved in the field of Social Development in the Region. This was planned with a view to help our interventions with the poor and the marginalised groups of people may become increasingly systematic, scientific, and effective.

In order to realize the same WRSSF decided three levels of capacity-building

Thus the first level would be the 'Top Level Functionaries' Training' for the Diocesan Directors of Social Works (DDSWs), Women Co-ordinators from the Dioceses, members of Diocesan Perspective Planning (DPP) Working Committees and Diocesan Project Selection Committees (DPSC) members.

The second level would be the 'Middle Level Functionaries' Training' for Directors of Organisations, Middle level managerial staff of Regional Forum and Diocesan Social Service Societies (DSSS).

The third level would be the 'Grassroots Level Functionaries' Training' for field staff animators of grass roots groups of DSSS and other organisations.

The Zonal Directors of the Regional Forum had decided to form a 'Zonal Resource Team' for their respective Zones to realize this goal. Thus WRSSF and the Zonal Directors' Forum proposed a four-phased "Training of Trainers" / 'Training of Animators' to form the Zonal Resource Team and equip this team with the necessary expertise to fulfill the above aim

The second thrust was an effort to come up with sustained strategy for documentation in the Region. Therefore, we have now in the Region, different Dioceses coming forward to sponsor the Quarterly Newsbulletin, WRSSF DIARY, each time focussing, and highlighting the activities of that particular Diocese.

Here we have presented the Capacity -Building Programmes in the chronological order of events.

# A. CAPACITY-BUILDING PROGRAMMES.

# Grassroots Level Functionaries' Training:

Gender Analysis: It was explained well to the participants that the levels of policy development for gender planning were:

WELFARE

ANTI-POVERTY

EOUITY

CONTROL

EMPOWERMENT

It was also highlighted that in the Gender Planning both men and women must be included for the meaningful and lasting change in the community / society.

In the legal education, the topics of free legal aid, consumer protection and Hindu Civil Code, The Indian Constitution, preparing affidavits, FIR, Police and one's rights, the difference between Criminal and Civil Proceedings and so on were discussed in detail.

In Social Analysis, they were made to think and reflect on situations in which people live, who is responsible for what happens in a situation and what steps people take, who is responsible for the situation and with the help of the animators how can they address the situation and so on.

Fr Patric Lemos, Fr Jose Kattekara and Mr Blaise D'Souza were directly responsible for this TOT.

2 Zonal TOA (Phase 1.) : Konkan Zone.

Mr. Dayanand Ambolkar, Fr. Andrew Rodrigues, Fr. Rocky Banz and Mr. Blaise D'Souza were responsible for this TOA.

Evaluation of the Training Sessions: This has been a typical feature of TOTs each time. Often the feeling of great satisfaction was expressed. The coming together has helped for new bonding and contacts for future collboration among themselves. The cultural Programmes were a regular feature, which have given them opportunities for leadership, organisational and creative skill formation. On the other how ever, the participants have felt that duration of the workshop could be for a minimum of 4 to 5 days.

#### TOA (Phase II)

#### Rational for the Second phase of TOA.

At each of the Training Programme of Phase I of the TOT Programmes, the participants were introduced to inputs on gender sensitisation and the 'Need for gender Sensitive Planning" - to involve both men and women for an equitable and sustainable development process. Thus for a second phase of the TOT / TOA, it was decided to give deeper inputs and amore comprehensive understanding on Gender and Development

(GAD) The Zonal Co-ordinators took note of those participants who had the ability to become trainers themselves in the near future.

At the evaluation of this TOA, there was much dissatisfaction expressed by the participants. Obviously the Resource person was not satisfactory. There was a felt need for Marathi language for the course, which the resource person did not know. The participants made concrete suggestions for the future programmes such as information regarding legal issues, how to handle an issue, problem solving, new economic policy, personality development, income generation, how to conduct community meetings and so on.

# IMPACT OF THE TOA PROGRAMMES IN THE REGION:

The following impact has been observed in the region as a result of the programmes.

a) The participants received orientation to community organisation.

b) They have learnt various methods of forming effective working groups in the community.

c) The different steps in the process of group formation

d) Motivation and leadership qualities of leaders

e) Second line of leadership of groups

f) Basic skills for effective community organisation

g) Participatory planning and tools for planning such as PRA

h) Knowledge of Panchayati Raj.

i) Knowledge of income generation / employment schemes and other people centred development schemes of the government

Knowledge of legal and human rights

k) Gender sensitivity.

#### Gujarat Zone:

Due to the Gujarat Earthquake that struck the whole of Gujarat State on January 26th 2001, WRSSF could not organise any TOA in the Gujarat zone. Since then, all our Directors of Social Service Societies, Social workers, animators and grassroot workers of Gujarat State were fully engaged in mobilising resources for the relief work of earthquake victims from February 1, 2001 to May 31, 2001. Hence, no TOA was organised for Gujarat Zone.

Gender awareness, Basic gender concepts, Exercise and discussion on roles and activities, Institution of Socialisation (The Gender Process Interactive Session), Approaches to women empowerment (group work Introduction to gender analysis and Planning Methodology, gender development (exercise and groupwork), Gender responsiveness & Development Organisations – Blue print for organisational change, group work and presentation of the action – plan.

The group presentation on the action plan came out with a specific design plan. This design plan included:-

- Identifying women's groups
- · Federate them
- Analyse their level of empowerment
- Workout ways and means to reach the level of control
- Enhancing participation of women at all levels and creating equal opportunities
- Taking up of various activities such as income generation programmes aimed at the economic empowerment of women.

At the end of the workshop the Diocesan Directors expressed that they were drawn to get A conceptual clarity of the question of Gender Development and they were further sensitised to the point of having a full time women co-ordinator at the diocese and regional levels.

Topics covered:

Different models of Development ( Charity model, Institutional Model and Input Model), Development as fight against injustice i.e. the aggressive way being Legalistic, Development seen as participatory by the people in the process of Development (PRA) and Animation Model. Besides these, Steven added one more as seen by him i.e. Development seen as working through people. This in other words means participation. This has the following steps / stages:-

- Clearly spelt out objectives
   Facilitation
- Planning
- Formation / Development
- Monitoring stage
- Evaluation / review / assessment stage.

#### The role of DPSC members were discussed as follows:-

- · Facilitating development process in the dioceses
- To be aware of groups / issues in the dioceses
- To know the needs / problems of potential partners
- To be able to analyse and prioritise programmes and proposals
- Evaluating & monitoring
- To ensure completion of programmes / reporting.

- Constitutional Norms for DPSC members
- Functional Norms for DPSC members

Later, application of facilitation skills at various stages such as planning stage, monitoring stage, evaluation stage were taken up and dealt with. The workshop was found to be extremely useful to the participants and they Suggested that perhaps there is a need to rename the DPSC as DPMC – Diocesan Project Managing Committee.

Centre for Social Action, The Archdiocesan Social Work Society of Bombay, conducted a One-day Capacity Building Programme for the Co-ordinators of Community Centres and for the Organisers of Other Church-based NGOs in the Archdiocese of Bombay. The topic was chosen on request by the participants at the previous Capacity Building Program, which was conducted on August 24, 2001 on Credit Societies and Self-Help Groups.

The specific objectives of this Program were a) to get to know the innovative women NGOs in Mumbai City b) to get to know some possible income generation / livelihood programs that are socially useful and economically productive and c) to plan out some community-based action-programmes for future either area –wise or parish-wise for livelihoods of marginalised people.

The training manual titled 'Innovative NGOs and Community-base Livelihood Programmes' for the occasion was released as Course material. A complimentary copy was given to each organisation present for the Program. The same Training Manual was presented to the DDSWs of the Western Region also later on.

#### Objectives of the workshop on Tribal Issues:

To introduce and initiate the Directors of Social Service Societies, the women co-ordinators of social work Centres and organisations, social activists and other interested collaborators in the field in the Western Region to the issues and problems faced by the tribals in the Western Region

To share among the participants themselves the various programmes initiated in

their respective dioceses

To work out a specific action plan to take up the issues concerning the tribals in the Western Region.

A round of questions and answers followed the input and later the participants insisted to have an in depth training programme for the core team of prison ministry for each of the 13 dioceses.

A personal visit by the participants to the Central Prison in Nashik was arranged for:

This visited included interaction with the prison authorities, with the inmates of the

prison - undertrials and convicted.

The visit helped the participants to see for themselves the various infrastructure facilities that are made available for under trials & convicts inside the prison such as work, healthcare, education, counselling, Savings, food arrangements and facilities offered to the prisoners.

Both the input and the visit have motivated the participants and the Directors to take up. The human rights issue concerning prisoners and their families. A two days workshop has been planned for the core teams of the Prison Ministry of the 13 dioceses of the western

region in July / August 2002.

# A FIELD VISIT TO THE DEVELOPMENT PROJECTS OF NASHIK DIOCESE

Date of visit 7 February, 2002 from 8 a.m. to 10 p.m.

Participants : 40 out of the 48 only managed to make this visit.

The first field visit was to the Sangamner Mission – Ahmednagar. The Director of the Mission FR. J. COELHO S.J gave input. This was followed by interaction by the mission staff and beneficiaries with the participants. This visit gave the participants an insight into how the Dalit and the marginalised groups have come up in life because of the efforts of the staff of the Mission especially with respect to health, education and agriculture.

The afternoon visit was to the Watershed Management Programm at Malegaon Pathar at Ahmednagar District. The Social Centre of Ahmednagar had initiated this programme.

A walk by the participants together with the villagers and the beneficiaries of the Watershed Programmes to the hills and terrain of the villages made the participants realise that through Watershed Management, the drought hit areas could be converted into green valleys producing paddy, fruits and vegetables and thus making the villagers self-reliant.

An interaction with the Mahila Mandal groups made the participants realise that even uneducated rural folk and women could rise up and become leaders of their Grampanchayat. The role of the Social Centre, an NGO, made the participants realise the importance of bringing people together on issues concerning the lives of the people.

# SOCIAL WORK DIRECTORS MEETING TOGETHER WITH BISHOP FILIPE NERI FERRAO.

This meeting was organised to review the past events of the Region and to plan for the next year.

Topics like the Endowment Fund, Prison Ministry, Gujarat Earthquake, Gender Development in the Region were taken up.

A decision has bee taken in the region with the collaboration with the Diocesan Directors to create the Endowment Fund for the Region. Every year an Archdiocese of the Region will contribute Rs. 10,000 a year and a Diocese will contribute Rs. 5000 each year to the Endowment Fund. This eventually will help the Regional Forum to stand on its feet.

# 3 Diocesan Capacity Building Programme(Vasai):

On the Occasion of the International Women's Day on March 10,2002, Shanti Seva Mandal, an NGO, together with Jyoti Nivas, Manor organised a full day awareness programme on Gram Panchayat and Gram Sabha. A total number of 1000 tribal women got together for this program. The purpose of the meeting was to make aware of the fact that the funds of the government would reach the grassroot tribal women at the grass root. This programme was organised to ensure that they are able to procure these funds, which is meant for their own development. Ms. Medha Patkar was the facilitator to give inputs on this topic. This Melawa has resulted in bringing the tribal women together to share the problems and achievements and strengthening the bond to take up further issues concerning their lives.


